PROBATIONARY JAIL OFFICER (\$27.49 per hour).

Benefits include health insurance, thirteen paid holidays, paid vacation, retirement plan, and furnished uniforms.  
You will receive notification, via U.S. Mail, of your written test date.

**All Probationary Deputy Applicants must meet the following requirements at the time the application is filed:**

U.S. Citizen  
Madison County resident within six months of hire  
Minimum of 21 years of age  
Valid Drivers License  
Clean police record  
High school diploma or GED

**\*Applicants will be REQUIRED to pass a POWER (Peace Officer Wellness Evaluation Report) test.**

POWER test cards can be obtained by contacting the SWIC Police Academy at (618) 222-5396.  
If you have taken/passed a POWER test in the last 12 months attach a copy.

*The physical power test is based on the minimum standards required for admission to the basic police course as set by the Illinois Local Government Law Enforcement Officers Training Board.*

**\*Applicants will be required to receive a passing score on a written exam.**

**All Probationary Jail Officer Applicants must meet the following requirements at the time the application is filed:**

U.S. Citizen  
Madison County resident within six months of hire  
Minimum of 21 years of age  
Valid Drivers License  
Clean police record  
High school diploma or GED.

\*Applicants will be required to receive a passing score on a written exam.

*Applicants are advised that these positions require very good motor skills, visual acuity, good hearing, and the ability to perform under stressful conditions. These are considered basic entry level officer positions.*

*Applicants must pass a thorough background investigation, polygraph test, and medical exam.*

***Prior drug use may eliminate applicant.***

*Applicants who successfully complete the application process will be placed on an eligibility list of qualified persons furnished to the Sheriff. This list will serve as the sole source for persons hired for these positions.*
