## Media Advisory

**WHO:** Madison County State's Attorney's Office to discuss texting and driving with local high school students as part of statewide "Drive Now. Text Later." campaign.

**WHEN:** Tuesday, November 20, 2012, 8:00 a.m. -2:30 p.m.

**WHERE:** Triad High School, 703 East Highway 40, Troy, IL;  
Driver's Education Classes

**SIGNIFICANCE:** Assistant State's Attorney Ellen Burford will again be speaking with Driver's Education students at Triad High School on Tuesday about the consequences of texting and driving. Illinois law prohibits composing, sending and reading electronic messages while driving (625 ILCS 5/12-610.2). Depending on their age, teenage drivers face serious repercussions with regards to obtaining and keeping their driver's license if they violate the texting and driving law. Drivers under 19 are prohibited from using a cell phone with or without a hands-free device. Additionally, drivers under 19 face restrictions on their licenses if found guilty of texting and driving.

Besides the legal consequences, the State's Attorney's Office will also remind students of the dangers of texting and driving. According to the *Virginia Tech Transportation Institute*, drivers who text are 23 times more likely to be in a car crash. In addition to civil penalties, drivers can also face charges of Reckless Homicide in the event of a fatal car crash occurring as a result of texting and driving.

State's Attorney Tom Gibbons came up with the idea as a way to use the resources of his office to reach out to various groups in the community to show them that actions have consequences. Gibbons pointed to a report from AAA that cited traffic accidents as the leading cause of death for people age 15-20. "I realize that we live in such a technology-driven world, but what I hope my prosecutors can convey to these kids is that they need to set down or turn off their phones and focus on driving when they're behind the wheel. Drive Now. Text Later. If not, there may be consequences that are simply not worth it in the long run."

Assistant State's Attorney Burford is a prosecutor in the Misdemeanor/Traffic Division. She will be asking the students in each class to take a pledge to not text and drive. Students will be offered extra credit in exchange for returning the pledge. Prosecutors visited Granite City on September 21st, Alton on September 26th, Collinsville on October 4th, Highland on October 11th, Edwardsville on October 16th, East Alton-Wood River on October 17th, Bethalto on October 17th-18th, Madison on October 19th and Roxana on October 24-25. The visit to Triad High School will complete presentations to all Madison County high schools, which was a goal of State's Attorney Gibbons. The State's Attorney's Office will continue visiting Driver's Ed Classes throughout the 2013-2014 school year as new classes begin.
